# WHAT DOES SGH WEALTH MANAGEMENT DO WITH YOUR PERSONAL INFORMATION?

#### What?

The types of personal information we collect and share depends on the product or service you have with us. This information can include:

- Tax Identification Number, Date of Birth, Telephone Number and Address
- Annual Income, Tax Bracket, Account Balances and Transaction History
- Net Worth, Assets and Employment History

When you are *no longer* our customer, we continue to share your information as described in this notice

### How?

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons companies can share their clients' personal information; the reasons SGH Wealth Management chooses to share; and whether you can limit this sharing.
